When do you need a Lease Termination? Some Rental Agreements require notice be sent if the landlord-tenant relationship will end. If you want to end your agreement early, use a Notice of Termination to officially communicate the need to end the agreement. For example, a yearly rental agreement may automatically renew unless one month or two month's notice is given. Advanced warning gives the Landlord time to find another renter and provides the Tenant enough time find a new home.
